The Parent/Guardian of a Participant under 18 years of age acknowledges and agrees that the Participant is primarily responsible for the Participant's safety and that the Team Leader will monitor the Participant's participation in the Program.

In consideration for iGEM allowing the Participant to participate in the Program, Participant (and the Parent/Guardian) of a Participant under 18 years of age for and on behalf of the Participant and the Parent/Guardian) assumes all risk of such participation and hereby releases iGEM and (except as expressly provided below) all of iGEM's directors, officers employees, volunteers, and agents from any and all claims for any injury of any kind to the Participant (and the Parent/Guardian) or other damages that may occur as a result of the Participant's participation in the Program, including without limitation any injuries or other damages that may be caused by the negligence of iGEM or negligence of any iGEM's directors, officers, employees, volunteers, or agents (including without limitation negligently failing to adequately investigate or screen mentors, volunteers, etc.), and agrees not to file any lawsuit or otherwise make any claim agains iGEM or any of iGEM's directors, officers, employees, volunteers, or agents for any such injury or other damages.
